As you are aware, Station 2 is progressing rapidly with an estimated completion date in early August. Several pieces of equipment needed for the station have lead times of approximately 8 to 10 weeks. Due to that lead time, and the estimated completion date of the station, I am requesting approval to order these pieces of equipment in hopes they will be delivered and installed in conjunction with Parrish Construction's estimated completion date.

Multiple authorized Arctic vendors were solicited for quotation with the lowest price presented by Municipal Equipment Company. Both vendors quoted identical products and quantities. It is my recommendation to purchase this equipment from Municipal Equipment Company for their quoted price of \$45,882.70 to include the optional warranty for an additional \$3,454.30 bringing the total price to \$49,377.

Both vendor guotes are attached to this memo for reference.

Re: Recommendation of Award Phase 6, Stages 1C and 2A

Cell Construction (Bid #23-24)

Houston County received three bids from a request for proposals to construct our next landfill cell of 9 acres. The bids were from CBP Environmental, Inc., Peed Bros., Inc., and Glover Construction Co., Inc. Bids were evaluated and scored for cost and performance criteria by our consultants, Atlantic Coast Consulting, Inc. The highest score awarded of 97 out of 100 total possible points was to CBP Environmental, Inc.

Public Works staff and Atlantic Coast Consulting, Inc. recommend awarding contract to **CBP Environmental, Inc. for the amount not to exceed \$6,210,597.48.** Included in the total amount is an opportunity for a 5% early completion bonus of the base bid if project is substantially complete within 80% of contract time.

6. Second Reading of Amendment to an Ordinance – Commissioner Talton

County Attorney Tom Hall will conduct a second reading of a proposed amendment to the Houston County Code of Ordinances followed by a public hearing. The proposed amendment will add a new article to Chapter 62 – Traffic and Vehicles titled Article III – Truck Traffic and Truck Parking to the Code of Ordinances. The proposed amendment will regulate truck traffic and parking in specific areas of Houston County.

The first reading of this proposed amendment to the Houston County Code of Ordinances was held at the June 20, 2023 Houston County Board of Commissioners meeting.
