## NOTICE TO VOTERS IN THE FOLLOWING PRECINCTS: PART OF MALL - NSES – NSMS - TMS - VHS ALL OF ELBC and HCHS

The Houston County Board of Elections adopted the following changes at their meeting, Tuesday, August 6, 2013. The meeting was held at 5:30 p.m. at the Houston County Government Building, 801 Main St., Perry. **The following proposals were adopted:** 

- 1. Move voters in the current (ELBC) Elberta precinct with the exception of those voters west of Elberta Road who are not in the city limits of Warner Robins to (RECR) Warner Robins Recreation Department.
- 2. Move voters in the county in the current (ELBC) Elberta precinct west of Elberta Road to (NSES) Northside Elementary School.
- 3. Move voters in the current (MALL) old Houston Mall precinct who live in the city limits of Centerville to include voters in the county on Anthony Ave., Bauman Dr. (Cir.), Bazemore Cir., Brown Dr., Crestwood Rd., Gena Dr., Valley Dr., Weaver Rd. and Webb St. to (CENT) Centerville City Hall.
- 4. Move voters in the current (NSES) Northside Elementary School precinct who live in the city limits of Centerville to include voters in the county who live in the area North of Giles Rd. South of Old Stone Crossing East of U.S. Highway 41 and West of Houston Lake to (CENT) Centerville City Hall. Voters on the following streets Claystone Ct., Gemstone Ct. and Limestone Tr., will still vote at (NSES) Northside Elementary School.
- 5. Move voters in the current (NSMS) Northside Middle School precinct who live in the city limits of Centerville to (CENT) Centerville City Hall.
- 6. Move voters in the current (TMS) Thomson Middle School precinct who live in the city limits of Centerville to (CENT) Centerville City Hall.
- Move voters in the current (VHS) Veterans High School precinct south of GA Highway
   96 East of Houston Lake to Mount Zion Rd. North of Mount Zion Rd. to Tidwell
   Rd. North of Tidwell Rd. to West of Moody Rd. to the newly created precinct of (CGTC) Central Georgia Technical College.
- 8. Move voters in the current (HCHS) Houston County High School precinct to the newly created (CGTC) Central Georgia Technical College precinct.
