### REGISTRATION/ELECTION SUPERVISOR REPORT:

The Georgia Secretary of State Elections Office mailed Cross-State and National Change of Address confirmation notices to voters. This process was done to ensure accurate voter rolls before the November General Election.

The Elections staff will attend continuing education training on July 20<sup>th</sup> and July 21<sup>st</sup>. The classes will be held at the Center for Elections office.

Logic and Accuracy Testing on voting equipment will begin Thursday, October 6 at 9:00 a.m. and continue each day until testing is complete.

Early Voting is October 17<sup>th</sup> – November 4<sup>th</sup> (Mon – Fri) 8:00 a.m. – 5:00 p.m. There are two Saturday voting dates, October 22<sup>nd</sup> and October 29<sup>th</sup> (9:00 a.m. – 5:00 p.m.). All early voting locations will open the same hours.

Election Day is November 8, 2022. Election Day polling locations hours are 7:00 a.m. – 7:00 p.m.

Poll worker training for the November 8, 2022 General Election is September 28<sup>th</sup> – 30<sup>th</sup> and October 6<sup>th</sup> – October 9<sup>th</sup>.


#### Old Business:
